



What are **Regular Members**, **Voting Members**, and **Board Members**?

Regular Members are the members of East Mountain Little League who have applied and been elected to serve as **regular** members. **Regular members** are voting members. The terms are used interchangeably. Regular members include current board members and officers, appointed managers/coaches, appointed umpires, and others who have been elected by the membership and are in good standing (paid dues).

Board Members are nominated from the regular membership and elected by the regular members annually. The officers of the board are elected by the board members. Board members serve a term of one year, from October 1 through September 30. are those persons n sincerely interested in active participation to further the objectives of East Mountain Little League may apply to become a Regular Member.

Regular (Voting) Members: Any adult volunteer, legally recognized parent/guardian of a player who is sincerely interested in furthering the objectives of East Mountain Little League may become a Regular (Voting) Member upon election and payment of dues. As per Little League International recommendation, East Mountain Little League has established a clearly defined group of regular members. The regular members attend the annual membership meeting which is held the third Saturday of September. The agenda of the annual membership meeting will include information about the condition of the league, financial information, review of the constitution, and the election of board members for the next season.

If you are interested in helping to ensure that East Mountain Little League continues to provide a quality service to the youth of our community, we encourage you to make the commitment of becoming a regular (voting) member of East Mountain Little League.

Board Members: Any regular member who is committed to continuing the mission of Little League may be nominated (by self or other member) to be considered for the board elections. Elected board members (board of directors) are the stewards of our league and are responsible for the day-to-day operations of the league, from preparing registration to running tryouts and drafts, ordering uniforms, scheduling games and umpires, and much more. After being elected to the board of directors, these board members will meet and elect the officers of the board.

If you are committed to actively furthering the objectives and mission of Little League and ensuring that East Mountain Little League is a quality program for the youth of our community, we strongly encourage you to volunteer to become a board member.
